### Visa Application to China

All foreigners must obtain an entry visa before proceeding to China. Exhibitors & Visitors are strongly recommended to process the application **one month before departure** from the country of origin.

### Exhibitors & Visitors with Invitation

All the applicants for visa are required to have an invitation letter from the Chinese authority. Our company will coordinate and forward the information of the application to the Chinese authorities for issuing the invitation letter which will be ready within 7 working days and presented to your company by fax or mail.

Upon receipt of this visa authorization, the applicant is required to present his / her passport, a recent photograph, a completed visa application form (available from local Chinese Embassy) and forward to the local Chinese Embassy or Consulate for completion of the formalities. Cost to issue of invitation letter for visa application is RMB 100 / person.

### ATTENTION:

1. Passports must be valid for at least SIX MONTHS beyond the intended date of entry into China.
2. Please make enough copies for each applicant and return the typewritten form to us before the deadline.
